PLEDGE OF ALLEGIANCE

THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE INTERIM VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. HUPKE, DR. MARCH, MR. BOWDEN, MR. HACK, AND MR. HAMM. TRUSTEE JONES WAS ABSENT. ALSO PRESENT WERE THE CLERK, ATTORNEY, ENGINEER, MR. FOX, MS. BORMET, MR. MITCHELL, AND CHIEF MORT.

CALL TO ORDER

ROLL CALL

MOTION BY HUPKE, SECONDED BY MARCH, TO APPROVE THE MINUTES OF THE MARCH 28, 2016, REGULAR VILLAGE BOARD MEETING AS WRITTEN. HUPKE, MARCH, BOWDEN, HACK, AND HAMM VOTING AYE; MOTION CARRIED.

MINUTES

MOTION BY HUPKE, SECONDED BY HACK, TO APPROVE THE PAYROLL AND TO APPROVE THE ACCOUNTS PAYABLE IN ALL CATEGORIZED FUNDS AS PRESENTED. HUPKE, HACK, MARCH, BOWDEN, AND HAMM VOTING AYE; MOTION CARRIED.

PUBLIC COMMENT - LIBRARY DIRECTOR, NOREEN BORMET, ANNOUNCED THAT THIS WEEK IS NATIONAL LIBRARY WEEK. THE LIBRARY HAS SCHEDULED A CLEAN UP YOUR FINES PROGRAM. THE SPRING BOOK SALE WILL BE THE 21st THROUGH THE 23rd OF APRIL.

PUBLIC COMMENT

CHIEF'S REPORT - CHIEF MORT REPORTED THAT THE PRESIDENT WILL BE SIGNING OFF ON THE EMERGENCY PLAN. TOMORROW THERE WILL BE A DISASTER EXERCISE IN MONEE.

REPORTS

ENGINEER - NONE

COMMUNITY DEVELOPMENT COMMITTEE - TRUSTEE MARCH REPORTED THAT THE COMMITTEE DISCUSSED THE WELCOME BAGS FOR NEW RESIDENTS. THE BUSINESSES SHOULD BE ENCOURAGED TO DONATE PROMOTIONAL ITEMS FOR THE BAGS. STANDARDIZING THE VILLAGE LOGO WAS DISCUSSED. USING THE VILLAGE PIN AS THE LOGO ON EVERYTHING WAS DISCUSSED. THE CLERK EXPLAINED THAT SHE HAD WORKED WITH INLAND ARTS AND GRAPHIC A COUPLE OF YEARS AGO AND WE CHANGED THE DIRECTION OF THE MILL. IT LOOKED FINE FOR THE ENVELOPES, BUT IT DIDN'T LOOK RIGHT AS STATIONARY. TRUSTEE MARCH SUGGESTED WORKING WITH GRAPHICS PEOPLE. TRUSTEE HUPKE SUGGESTED HOLDING A CONTEST FOR A NEW LOGO. THE COMMUNITY DEVELOPMENT COMMITTEE ALSO DISCUSSED THE VILLAGE ENTRY SIGNS; THE SIDEWALK SURVEY TO BE DONE BY TRUSTEE MARCH, TRUSTEE JONES, AND ADAM JONES ON APRIL 29th, AND THE APPLICATION FOR TREE CITY USA.

THE ORDINANCE FOR A STOP SIGN ON RATHJE ROAD WAS DISCUSSED AND TABLED FROM THE LAST BOARD MEETING. MR. FOX, MR. MITCHELL, AND ANOTHER RATHJE ROAD RESIDENT WERE PRESENT TO SPEAK ON THE ISSUE. THEY THOUGHT THE POLICE SHOULD ISSUE MORE SPEEDING TICKETS. THEY OFFERED MORNING AND EVENING TIMES WHEN MOST OF THE SPEEDING OCCURRED. CHIEF MORT STATED THAT WHEN THE SPEEDING TICKETS GO TO COURT, THE TICKETS ARE DISMISSED FOR ANYTHING LESS THAN A CERTAIN AMOUNT OF MILES PER HOUR OVER THE SPEED LIMIT. THE LOSS OF PARKING IF THE STOP SIGN WERE TO BE INSTALLED WAS DISCUSSED. TRUSTEE HUPKE STATED THAT OAK STREET HAS THE SAME

SPEEDING ISSUES EVEN THOUGH THERE ARE STOP SIGNS. TRUSTEE HACK SPOKE ABOUT THE ELECTRIC RADAR SIGN THE BOARD HAD PREVIOUSLY DISCUSSED. THE RADAR SIGN ALSO COLLECTS DATA. CHIEF MORT WILL ORDER THE ELECTRIC RADAR SIGN AND THE POLICE WILL CONTINUE THE ENFORCEMENT OF THE SPEED LIMIT. WHEN ASKED, THE RATHJE ROAD RESIDENTS WERE NOT IN FAVOR OF THE RATHJE ROAD STOP SIGN.

MOTION BY MARCH, SECONDED BY HUPKE, TO TABLE THE RATHJE ROAD STOP SIGN ORDINANCE UNTIL THE NEXT BOARD MEETING. MARCH, HUPKE, HACK, BOWDEN, AND HAMM VOTING AYE; MOTION CARRIED.
