THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE INTERIM VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. HUPKE, DR. MARCH, MR. BOWDEN, AND MR. HACK. TRUSTEE JONES WAS ABSENT. ALSO PRESENT WERE THE CLERK, ATTORNEY, MS. BORMET, AND MS.MURAWSKI.

MOTION BY HUPKE, SECONDED BY MARCH, TO APPROVE THE MINUTES OF THE SEPTEMBER 28, 2015, REGULAR VILLAGE BOARD MEETING AS WRITTEN. HUPKE, MARCH, BOWDEN, AND HACK, VOTING AYE; MOTION CARRIED.

**FARMERS MARKET
2016 SCHEDULE**

MOTION BY MARCH, SECONDED BY HACK, TO APPROVE THE 2016 FARMERS MARKET SCHEDULE AND THE CLOSURE OF NORTH STREET BETWEEN SECOND STREET AND RAILROAD STREET FOR EACH EVENT. MARCH, HACK, BOWDEN, AND HUPKE VOTING AYE; MOTION CARRIED.

FOR THE COMMITTEE OF THE WHOLE MEETINGS. SOME TRUSTEES THOUGHT THAT 5:30 WOULD BE TOO EARLY FOR THE PUBLIC TO ATTEND THE COMMITTEE OF THE WHOLE MEETING. THE CONSENSUS OF THE BOARD WAS TO LEAVE THE MEETING TIMES AS THEY ARE.

**GENERAL DISCUSSION
MEETING TIMES**

A MEETING HAD TAKEN PLACE BETWEEN VILLAGE ENGINEERS GOLEM AND CALOMBARIS, THE VILLAGE PRESIDENT, THE ADMINISTRATOR, AND MR. PINTAR REGARDING QUIET ZONE FOR THE TRAINS IN THE VILLAGE. THE DIFFERENT CROSSINGS AND THE NEEDS OF EACH WERE DISCUSSED. THE WILSON CROSSING, WHICH IS STRICTLY PEDESTRIAN, WOULD HAVE TO BE BLOCKED OFF COMPLETELY; FENCING WOULD HAVE TO BE INSTALLED ALONG THE TRACKS AT WILMINGTON ROAD; THE PROXIMITY OF RAILROAD STREET AT CRAWFORD, MAIN, AND CORNING WOULD BE A MAJOR ISSUE; IF ANY INCIDENT OCCURS, THE QUIET ZONE WOULD BE TAKEN AWAY; AND THE COST WOULD BE APPROXIMATELY \$125,000.00. IT WAS SUGGESTED THAT IF THE BOARD WANTED TO LOOK INTO THE MATTER FURTHER, IT SHOULD GO TO COMMITTEE.

THE PRESIDENT ANNOUNCED THAT IF ANY TRUSTEE WANTED TO POST ANYTHING ON THE VILLAGE FACEBOOK PAGE TO LET HIM KNOW.
