ENGINEER REPORT - REGARDING THE RTE 50 & CORNING INTERSECTIONS - THE ACQUISITION OF TWO PARCELS IS STILL NOT RESOLVED, WHICH WILL MEAN A MARCH 2017 IDOT LETTING FOR THE PROJECT.

RATHJE ROAD IS SCHEDULED FOR THE SUMMER OF 2018. THE PROJECT SHOULD BE FINISHED BEFORE SCHOOL STARTS.

THE CORNING AVENUE RESURFACING PROJECT WAS SCHEDULED FOR 2018. THE ENGINEER INQUIRED IF THE VILLAGE WOULD RATHER CHANGE IT TO 2019? THE BOARD WILL DISCUSS THE ISSUE.

ADMINISTRATIVE OVERSIGHT COMMITTEE - TRUSTEE HUPKE REPORTED THAT THE COMMITTEE DISCUSSED ELIMINATING THE CLASS B LIQUOR LICENSE CLASSIFICATION AND COMBINING THE C AND C-1 CLASSIFICATION, THE NO CARRYOUT SALES AFTER MIDNIGHT RULE FOR ALL LIQUOR LICENSE CLASSES, AND RAISING THE LIQUOR LICENSE FEES. THE COMMITTEE DISCUSSED CAFÉS AND NOT CREATING A CLASSIFICATION FOR CAFÉS. INCREASING THE LIQUOR LICENSE FEES OVER A PERIOD OF TIME RATHER THAN ALL AT ONCE WAS DISCUSSED. THE COMMITTEE DISCUSSED WHETHER OR NOT TO RAISE THE \$1.00 PER HOUR STIPEND FOR WAIVING THE VILLAGE HEALTH INSURANCE AND THE CONSENSUS WAS TO LEAVE THE STIPEND AS IT IS. THE HEALTH INSURANCE WAS DISCUSSED IN GENERAL WITH EMPLOYEE PREMIUM PARTICIPATION. THEY WOULD LIKE AN INSURANCE WORKSHOP WITH GALLAGHER.

THE BOARD DISCUSSED THE FEES AND THE CREATION OF THE CAFÉ CLASSIFICATION.
