PUBLIC COMMENT

THE BOARD DISCUSSED THE ORDINANCE CREATING A CLASS V LIQUOR LICENSE FOR D.A.G. GROUP, INC. / G. BAUMGARTNER d/b/a VEGAS CAFÉ TO BE LOCATED AT 422 GOVERNORS HIGHWAY, SUITE 1. THE BOARD DISCUSSED THE GAMING CAFÉ HOURS, AND THE TYPE OF FOOD TO BE SERVED. MR. BAUMGARTNER WAS PRESENT TO EXPLAIN THAT THE FOOD WOULD BE FROZEN PIZZA, HOT DOGS, AND SANDWICHES CATERED FROM SUBWAY. THE MENU MAY BE CHANGED DEPENDING ON THE NEEDS OF THE CLIENTELE. THERE WOULD BE A STAFF OF ONE, UNLESS MORE WOULD BE DEEMED NECESSARY. FIVE GAMING MACHINES ARE PLANNED. MR. BAUMGARTNER'S HOPE IS TO BE ON THE STATE AGENDA FOR APPROVAL IN FEBRUARY WITH A MARCH 1 OPENING DATE. HE WILL SUBMIT HIS PROOF OF LIQUOR LIABILITY INSURANCE, BOND, AND BUSINESS REGISTRATION APPLICATION ON THURSDAY.
