**PLEDGE OF ALLEGIANCE**

THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE VILLAGE PRESIDENT, RICHARD DURAN, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. REICHERT, MR. HUPKE, MR. WICKER, MR. HACK, MR. CALLAHAN, AND MR. **ENGINEER REPORT**

THE PROJECTS DISCUSSED AT EARLIER MEETINGS INCLUDING STREET PAVING AND EMERGENCY GENERATORS FOR THE LIFT STATIONS WERE REVISITED. THE WILMINGTON ROAD BIKE PATH WAS DISCUSSED. TRUSTEE CALLAHAN STATED THAT HE HAD SPOKEN TO COUNTY WHO INDICATED THAT THE BIKE PATH WOULD BE APPROVED AS LONG AS THE REQUIREMENTS WERE MET. MR. GRAY STATED THAT THE \$100,000.00 GRANT WOULD NOT COVER HALF OF THE ESTIMATED COST OF THE BIKE PATH. WE WOULD HAVE TO SCRAP SOME OF THE PLANNED STREET REPAVING FOR THE FUNDS NEEDED TO COMPLETE THE PROJECT. SPECIAL ASSESSMENTS WERE DISCUSSED AS AN OPTION.

**GRANT SCOPE OF WORK**

THE VILLAGE MAY NOT PROHIBIT THE CULTIVATION AND DISPENSING SITES FOR MEDICAL MARIJUANA FROM LOCATING IN THE VILLAGE, BUT THE LAW ALLOWS THE VILLAGE TO ADOPT ZONING REGULATIONS TO PLACE THE FACILITIES IN APPROPRIATE LOCATIONS WITH REASONABLE CONDITIONS. THE PLANNING/ZONING COMMISSION HAS RECOMMENDED

**ORD. 13-27  
MEDICAL CANNABIS**

REQUIRING A SPECIAL USE PERMIT AND ONLY BE AVAILABLE IN THE I-2 INDUSTRIAL CLASSIFICATION.

MOTION BY FORSYTHE, SECONDED BY REICHERT, TO ADOPT THE PLANNING/ZONING FINDING OF FACTS AND ADOPT ORDINANCE 13-27 – AN ORDINANCE AMENDING CHAPTER 157 (ZONING CODE) OF THE PEOTONE ZONING ORDINANCE OF THE CODE OF PEOTONE CONCERNING REGULATION OF MEDICAL CANNABIS. FORSYTHE, REICHERT, HUPKE, WICKER, HACK, AND CALLAHAN VOTING AYE; MOTION CARRIED.
