THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE VILLAGE PRESIDENT, RICHARD DURAN, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. REICHERT, MR. HUPKE, MR. WICKER, MR. HACK, MR. CALLAHAN, AND MR. TRUSTEE FORSYTHE INQUIRED ABOUT THE PROGRESS ON THE WILMINGTON RD. SIDEWALK PROJECT. MR. GRAY STATED THAT WE WERE WAITING FOR THE GRANT AGREEMENT TO COME BACK FROM THE STATE.

TRUSTEE HACK INQUIRED THAT IF WE DID NOT RECEIVE THE GRANT, COULD THE FUNDS WE BUDGETED FOR THE PROJECT BE USED FOR OTHER SIDEWALKS IN THE VILLAGE THIS YEAR. MR. GRAY RESPONDED THAT IF THE GRANT WAS NOT RECEIVED IN TIME TO DO THE WILMINGTON ROAD PROJECT THIS YEAR, FUNDS WOULD HAVE TO BE APPROPRIATED IN NEXT YEAR'S BUDGET FOR THE PROJECT. MOTION BY REICHERT, SECONDED BY WICKER, TO APPROVE CHECK #30086 IN THE AMOUNT OF \$265,697.36 TO THE STATE OF ILLINOIS TREASURER FOR THE 2009 RATHJE ROAD RECONSTRUCTION PROJECT. REICHERT, WICKER, HACK, FORSYTHE, CALLAHAN, AND HUPKE VOTING AYE; MOTION CARRIED.

THE FEDERAL GOVERNMENT, THROUGH IDOT, HAS AWARDED A PLANNING GRANT TO WILL AND KANKAKEE COUNTIES. PLANNING GRANT FUNDING WOULD BE COMPRISES OF 80% FEDERAL, 10% IDOT, AND 10% VILLAGE FOR A \$37,500.00 PROJECT.

ILLIANA CORRIDOR GRANT

MOTION BY WICKER, SECONDED BY REICHERT, TO APPROVE PARTICIPATION IN THE ILLIANA CORRIDOR PLANNING GRANT. WICKER, REICHERT, HUPKE, HACK, FORSYTHE, AND CALLAHAN VOTING AYE; MOTION CARRIED.

PRESIDENT DURAN STATED THAT HE HAS HAD CONVERSATIONS WITH SEVERAL TRUSTEES REGARDING OUR WILLINGNESS TO WORK WITH NEW BUSINESSES. HE STATED THAT WE ARE ACTUALLY WORKING WITH A HARDWARE COMPANY WHICH SEEMS PROMISING AT THIS TIME. HE HOPES THE FOLKS WILL JUST BE PATIENT. HE SAID WE ARE ACTIVELY SEEKING BUSINESS AND WE ARE WILLING TO WORK WITH THEM. TRUSTEE CALLAHAN STATED HE HAD HEARD THE SAME RUMORS BUT, HAD NOT SEEN US TURN ANYONE AWAY. TRUSTEE

GENERAL DISCUSSION

FORSYTHE INQUIRED IF THE TRUSTEES WERE NOTIFIED RIGHT AWAY WHEN A BUSINESS APPROACHED US OR JUST WHEN IT GETS SERIOUS. THE PRESIDENT RESPONDED THAT THE TRUSTEES WERE NOTIFIED WHEN THE DISCUSSION BECOMES SERIOUS.

TRUSTEE HUPKE DISCUSSED THE WEATHER SIREN GOING OFF AFTER THE SEVERE WEATHER HAS PASSED US. THE PRESIDENT EXPLAINED THE PROCESS INVOLVED IN SETTING OFF THE SIREN AND THE PROCEDURAL MODIFICATIONS WHICH HAVE BEEN DISCUSSED AT THE EASTCOM MEETINGS. TRUSTEE CALLAHAN STATED THAT ACTIVATING THE SIRENS WHEN IT IS NOT NECESSARY MAY CAUSE THE PEOPLE NOT TO PAY ATTENTION WHEN A STORM IS PRESENT. CHIEF MORT STATED THAT HE AND MR. GRAY MONITOR THE WEATHER ALL OF THE TIME.

TRUSTEE HUPKE INQUIRED ABOUT THE NEW STREET SIGNS. MR. GRAY RESPONDED THAT THE NEW SIGNS WERE BEING INSTALLED. HE INQUIRED ABOUT THE PROCEDURE TO FILL THE OPEN POSITION ON THE PLANNING/ZONING COMMISSION AND WHETHER WE ADVERTISE TO FILL THE POSITION. PRESIDENT DURAN RESPONDED THAT HE REQUESTS SUGGESTIONS FROM THE STAFF.

SEVERAL TRUSTEES INQUIRED ABOUT RECEIVING THE BOARD PACKETS EARLIER IN THE WEEK SO THEY WOULD HAVE MORE TIME TO RESEARCH THE AGENDA ITEMS MORE THOROUGHLY.

TRUSTEE HUPKE THANKED EVERYONE INVOLVED WITH THE CAR CRUISE. HE ALSO THANKED THE AMERICAN LEGION FOR THE GREAT JOB FOR THE COINING LAST SUNDAY. HE STATED THAT IT WAS A GREAT PROGRAM.

MOTION BY HUPKE, SECONDED BY FORSYTHE, TO ADJOURN THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES AT 7:59 P.M. HUPKE, FORSYTHE, CALLAHAN, HACK, WICKER, AND REICHERT VOTING AYE; MOTION CARRIED.
