THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE INTERIM VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. JONES, DR. MARCH, MR. BOWDEN, MR. HACK, AND MR. HAMM. TRUSTEE HUPKE WAS ABSENT. ALSO PRESENT WERE THE CLERK, ADMINISTRATOR, ATTORNEY, ENGINEER, POLICE CHIEF, MS. BORMET, MS. BUSICH, MEMBERS OF THE THATCHER FAMILY, MS. EAHEART, MS. BIEDRON, AND MR. VELASCO.

ROLL CALL

MOTION BY MARCH, SECONDED BY JONES, TO APPROVE THE MINUTES OF THE FEBRUARY 22, 2016, REGULAR VILLAGE BOARD MEETING AS WRITTEN. MARCH, JONES, HACK, BOWDEN, AND HAMM VOTING AYE; MOTION CARRIED.

MINUTES

MOTION BY HACK, SECONDED BY HAMM, TO APPROVE THE PAYROLL AND TO APPROVE THE ACCOUNTS PAYABLE IN ALL CATEGORIZED FUNDS AS PRESENTED. HACK, HAMM, BOWDEN, MARCH, AND JONES VOTING AYE; MOTION CARRIED.

PAYROLL & ACCTS. PAYABLE

PUBLIC COMMENT - MS. BUSICH ADDRESSED THE BOARD REGARDING PATRONS OF THE NEIGHBORING BUSINESSES STANDING AND SMOKING IN FRONT OF HER BUSINESS ON SECOND STREET. THE RECEPTACLES ARE NOT BEING USED AND THE CIGARETTE BUTTS LITTERING THE SIDEWALK. THE PRESIDENT RESPONDED THAT THERE HAS BEEN DISCUSSION WITH THE CHIEF AND THE BUSINESS OWNERS IN THE PAST REGARDING THE ISSUE. COMMUNITY GARAGE SALE JUNE 17-18, 2016

MOTION BY BOWDEN, SECONDED BY HACK, TO APPROVE THE CHAMBER OF COMMERCE REQUEST TO HOLD THE COMMUNITY GARAGE SALE ON JUNE 17-18, 2016, WITH THE VILLAGE WAIVING THE \$5.00 GARAGE SALE FEE. BOWDEN, HACK, HAMM, MARCH, AND JONES VOTING AYE; MOTION CARRIED.

LIQUOR ORDINANCE CHANGE

THERE HAD BEEN DISCUSSION OF POSSIBLE CHANGES TO THE LIQUOR ORDINANCE AT THE FEBRUARY 1, 2016, OPEN FORUM MEETING WITH THE LIQUOR LICENSE HOLDERS. THE VILLAGE BOARD DISCUSSED THE SUNDAY SALES HOURS, GAS STATION ALCOHOL SALE

HOURS, AND HARD LIQUOR AS THE GAS STATIONS AS THE ITEMS HAD BEEN PRESENTED AT THE FEBRUARY 1, 2016, MEETING. THE CONSENSUS OF THE BOARD WAS TO CHANGE THE ALCOHOL SALES ON SUNDAY FROM 11:00 A.M. TO 6:00 A.M., TO STOP GAS STATION ALCOHOL SALES AT MIDNIGHT, AND NOT TO ALLOW HARD LIQUOR SALES AT GAS STATIONS. AN ORDINANCE REFLECTING THE CHANGES WILL BE PRESENTED AT THE NEXT BOARD MEETING. CHIEF MORT STATED THAT HE HAD SURVEYED THE SURROUNDING COMMUNITIES REGARDING THE LIQUOR LICENSE FEES AND PEOTONE WAS LOW. THE BOARD WILL VISIT THE LIQUOR LICENSE FEES IN THE FUTURE FOR A POSSIBLE INCREASE FOR THE 2017/2018 LICENSES.

ADMINISTRATOR SPATHIS INFORMED THE BOARD THAT HE HAD REACHED OUT TO SURROUNDING COMMUNITIES FOR INFORMATION ON DOWNTOWN MARKETING GROUPS. HE AND THE PRESIDENT HAD A MEETING WITH ONE GROUP. HE ASKED FOR DIRECTION FROM THE BOARD ON WHETHER OR NOT TO CONTINUE DIALOG WITH THE GROUP. THE COST WOULD BE APPROXIMATELY \$3,000.00- \$4,000.00 PER MONTH. MR. SPATHIS EXPLAINED THAT THE GROUP WOULD MAKE CONTACT WITH AREA LAND OWNERS AND WITH THE BUSINESSES WE HAVE TOLD THEM WE WOULD LIKE IN THE DOWNTOWN AREA. THE CONSENSUS OF THE BOARD WAS TO HAVE THE GROUP GIVE A PRESENTATION AT A MEETING.

DOWNTOWN MARKETING
GROUP

THE VILLAGE HAS BEEN CONTACTED WITH A REQUEST TO OPEN A CAFE GAMBLING ESTABLISHMENT IN THE DOWNTOWN AREA. THE FOOD WOULD BE PREPACKAGED SANDWICHES AND THE LIKE IN VENDING MACHINES. THE CURRENT LIQUOR ORDINANCE HAS NO CLASSIFICATION FOR AN ESTABLISHMENT OF THAT TYPE. THE CONSENSUS OF THE BOARD WAS THAT IF AN ESTABLISHMENT OF THAT TYPE WERE TO BE ALLOWED IT WOULD BE BETTER SUITED ON RTE. 50 AND NOT IN THE DOWNTOWN AREA.

CAFE GAMBLING

THE COMMUNITY DEVELOPMENT COMMITTEE HAD DISCUSSED A CLEAN-UP DAY FOR THE VILLAGE. THE CLEAN-UP DAY WILL BE SCHEDULED FOR APRIL 30, 2016, FROM 8:00 A.M. UNTIL NOON. THE BOY AND GIRL SCOUTS WILL BE CONTACTED FOR PARTICIPATION AND HOPEFULLY RESIDENTS WILL VOLUNTEER AS WELL. THE SCAVENGER SERVICE HAS BEEN CONTACTED AND WILL DONATE A ROLL-OFF FOR THE EVENT. THE PUBLIC WORKS DEPARTMENT WILL PICK UP THE GARBAGE BAGS AS THEY ARE FILLED AND TAKE THEM TO THE ROLL-OFF.
