THE ½ MILE CLEAN OUT WOULD BE \$7,800.00. THE ISSUE WAS DISCUSSED IN REGARD TO THE DRAINAGE DISTRICT. THE DRAINAGE DISTRICT DOES NOT CLEAN OUT TRIBUTARIES. THE BOARD DISCUSSED THE VILLAGE RESPONSIBILITY SINCE THE TRIBUTARY WAS OUTSIDE THE VILLAGE LIMITS. THE BOARD DISCUSSED THE VILLAGE BUDGET. WE HAVE NO PROVISION IN THIS YEAR'S BUDGET FOR THAT PROJECT. AT BUDGET PREPARATION TIME WE CAN DISCUSS THE ISSUE AGAIN AND DECIDE ON OUR LEVEL OF PARTICIPATION.
