MINUTES OF JANUARY 21, 2021

THE SPECIAL MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 2:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE ACTING VILLAGE PRESIDENT, PETER MARCH, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MR. JONES, MS. SLUIS, MR. PARKER, MR. HAMM (BY REMOTE ACCESS) AND MR. BOWDEN. TRUSTEE MAREVKA WAS ABSENT. ALSO PRESENT WERE THE VILLAGE CLERK AND THE VILLAGE ADMINISTRATOR. JOINING BY REMOTE ACCESS WERE MR. HENNKE, MR. HANSEN, MS. KELLY, MS. BORMET, AND MS. DAFOE, MR. SELLS, MR. CHAMBERS, MR. DALY, MR. TATTERSALL, MS. ARENS, MS. ZEEBER, MR. CROSS, AND MR. TONELLI.

CALL TO ORDER

ROLL CALL

THE PURPOSE FOR THE SPECIAL VILLAGE BOARD MEETING WAS TO VIEW THE CONCEPT DESIGN IDEAS FROM THE VILLAGE BOARD FOR RUETTIGER, TONELLI & ASSOCIATES, INC. AND UPLAND DESIGN, LTD REGARDING THE PROPOSED DOWNTOWN STREETScape PROJECT. MS. KELLY FROM UPLAND DESIGN LTD EXPLAINED THAT THEY WOULD DISCUSS THE EXISTING CONDITION OF THE DOWNTOWN AREA AND WOULD DO AN IDEA IMAGE REVIEW. THE PARTICIPANTS JOINING THE MEETING WOULD VOTE ON THE CONCEPTS PRESENTED WHICH WOULD GUIDE THEM TO DESIGN A FINAL PLAN FOR THE DOWNTOWN AREA. THE PLANNED AREA WOULD BE FROM E. CRAWFORD STREET TO CORNING AVENUE AND FROM FIRST STREET TO RAILROAD STREET. THE VISIONS TO BE DISCUSSED AND VOTED ON BY THE PARTICIPANTS WOULD INCLUDE THE TYPE OF PAVING FOR THE AREA (CONCRETE, BRICK, PAVERS, OR A COMBINATION), THE TYPE OF PARKING (ANGLED ON BOTH SIDES OR ON ONE SIDE, OR PARALLEL), CHANGING TO ONE-WAY STREETS, TREES, LANDSCAPE ISLANDS, TYPES OF SEATING AND BENCHES, DIFFERENT TYPES OF STREET LIGHTING, A POSSIBLE WATER FEATURE, STREET SIGNS, GATEWAY ELEMENTS, AND FESTIVAL EVENT SPACES INCLUDING MOVEABLE FURNITURE. THE DESIGN FIRM WOULD THEN TAKE ALL OF THE COMMENTS AND PREFERENCES DISCUSSED AND COMPILER IT INTO A FINAL PLAN FOR BOARD REVIEW AND THEN PRESENTED TO THE RESIDENTS AT A PUBLIC MEETING.
