SHOP QA HAD BEEN DISCUSSED AT THE PREVIOUS BOARD MEETING. MR. GRAY HAS NOT HAD THE OPPORTUNITY TO TALK TO THE CHAMBER BOARD OF DIRECTORS; HOWEVER, HE DID SPEAK WITH THE BUSINESS EXPO COMMITTEE, SOME OF WHOM ARE MEMBERS OF THE CHAMBER OF COMMERCE. THEY, OF COURSE, COULD NOT SPEAK FOR THE CHAMBER BOARD OF DIRECTORS, BUT DID NOT FEEL THE CHAMBER WOULD PARTICIPATE IN THE PROGRAM. THE VILLAGE ATTORNEY INFORMED THE BOARD OF A FEW CHANGES WHICH SHOULD BE MADE TO THE SHOP QA CONTRACT BEFORE THE BOARD WAS TO TAKE ACTION ON IT. THE BOARD WOULD LIKE MORE FEEDBACK FROM THE CHAMBER AND RESIDENTS BEFORE MAKING A DECISION.

THE DEVELOPERS OF THE MEYERS GLEN SUBDIVISION HAVE REQUESTED A LETTER OF CREDIT REDUCTION. THE BOARD WAS INFORMED THAT A PUNCH LIST WAS SENT TO THE DEVELOPERS WITH ITEMS DATING BACK TO 2005 WHICH HAVE NOT BEEN COMPLETED. THREE MAJOR ITEMS, THE POND, THE FENCE, AND CORRECTION TO THE STORM SEWER ON CORNING AVENUE, ARE HIGH PRIORITY ITEMS AND SHOULD BE COMPLETED AS SOON AS POSSIBLE. THE ENGINEER RECOMMENDS CORRESPONDENCE TO THE DEVELOPER WITH A THIRTY (30) DAY TIME LIMIT TO SHOW SUBSTANTIAL PROGRESS OR THE VILLAGE WILL PULL ON THE LETTER OF CREDIT.

MOTION BY LIBERATORE, SECONDED BY WICKER, TO DIRECT THE VILLAGE ENGINEER TO EXPRESS THE VILLAGE BOARD'S CONCERN TO THE DEVELOPERS OF MEYERS GLEN OVER THE FAILURE TO COMPLETE THE POND, FENCE AND THE CORRECTION TO THE STORM SEWER IN A TIMELY MANNER AND NOTIFYING THE DEVELOPERS THAT SUBSTANTIAL PROGRESS, AS DETERMINED BY THE VILLAGE ENGINEER, MUST BE MADE WITHIN THIRTY (30) DAYS OR THE VILLAGE BOARD WILL CONSIDER DRAWING ON THE LETTER OF CREDIT.
