MOTION BY JONES, SECONDED BY MAREVKA, TO ADOPT THE FIVE-YEAR 2019-2024 POLICE UNION CONTRACT/ AGREEMENT BETWEEN THE VILLAGE OF PEOTONE AND INTERNATIONAL BROTHERHOOD OF TEAMSTERS LOCAL 700 — 2018-2024. JONES, MAREVKA, BOWDEN, HAMM, PARKER, AND MARCH VOTING AYE; MOTION CARRIED.

THE VILLAGE ATTORNEY EXPLAINED THE THREE-YEAR PUBLIC WORKS UNION CONTRACT BETWEEN THE VILLAGE OF PEOTONE AND THE INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 399.

MOTION BY PARKER, SECONDED BY MAREVKA, TO ADOPT THE THREE-YEAR 2019-2022 PUBLIC WORKS UNION CONTRACT / LABOR AGREEMENT BETWEEN THE VILLAGE OF PEOTONE AND INTERNATIONAL UNION OF OPERATING ENGINEERS LOCAL 399 – JANUARY 1, 2019-MARCH 31, 2022. PARKER, MAREVKA, JONES, MARCH, HAMM, AND BOWDEN VOTING AYE; MOTION CARRIED.

THE CONSULTING AGREEMENT EXTENDS THE CURRENT AGREEMENT AN ADDITIONAL SIX MONTHS WITH GMT MANAGEMENT CONSULTING / GENE STEINMARCH FOR ECONOMIC DEVELOPMENT SERVICES. THE BOARD DISCUSSED THE AGREEMENT. A TYPO WAS FOUND ON "EXHIBIT A" REGARDING EXPENSES OUTSIDE OF THE RICHTON PARK AREA; THE SENTENCE WAS STRICKEN FROM THE AGREEMENT. THE BOARD ALSO CHANGED LETTER "G" TO MONTHLY REPORTS.

GMT CONSULTING AGREEMENT MOTION BY MARCH, SECONDED BY JONES, TO APPROVE THE SIX-MONTH AGREEMENT WITH GMT MANAGEMENT CONSULTANTS / GENE STEINMARCH, FOR ECONOMIC DEVELOPMENT SERVICES AT \$400.00 PER MONTH WITH THE CHANGES IN THE AGREEMENT OF STRIKING THE SENTENCE PERTAINING TO RICHTON PARK AND CHANGING THE REPORTS TO MONTHLY REPORTS. MARCH, JONES, MAREVKA, BOWDEN, HAMM, AND PARKER VOTING AYE; MOTION CARRIED.

THE BOARD AGAIN DISCUSSED THE POSSIBILITY OF AN ADDITIONAL CONTRIBUTION TO THE POLICE PENSION FUND. MR. ROCK WAS PRESENT TO STATE AGAIN THAT THE DEMAND ON THE POLICE PENSION FUND IS GREATER THAN THE TOTAL CONTRIBUTIONS. EVEN THOUGH THE VILLAGE MAKES THE YEARLY CONTRIBUTION, THE FUND HAS BECOME AN UNFUNDED LIABILITY OF JUST UNDER \$5 MILLION. THE INVESTMENT OPPORTUNITIES ARE LIMITED UNTIL THE FUND REACHES \$2 MILLION. AN ADDITIONAL CONTRIBUTION FROM THE VILLAGE WOULD ALLOW THE PENSION FUND TO REACH THE THRESHOLD TO MAKE STOCK MARKET INVESTMENTS. THE BOARD DISCUSSED AN ADDITIONAL CONTRIBUTION NOW OR LATER WHEN THEY HAVE DECIDED WHAT THEY WILL DO WITH THE FUNDS FROM THE SALE OF THE WATER/SEWER SYSTEMS. THE BUDGET DISCUSSIONS WILL BEGIN SOON AND THE BOARD WILL INCLUDE THE ADDITIONAL CONTRIBUTION IN THE DISCUSSION.

POLICE PENSION FUND CONTRIBUTION

THE ADMINISTRATOR EXPLAINED THAT WITH THE SCOPE OF WORK TO BE DONE AT THE NEW PUBLIC WORKS BUILDING ON RATHJE ROAD, THE VILLAGE SHOULD PREPARE SPECIFICATIONS AND ADVERTISE FOR BIDS FOR A GENERAL CONTRACTOR FOR THE PROJECT. \$100,000.00 WAS BUDGETED THIS FISCAL YEAR, OF WHICH \$90,000.00 IS LEFT. THE PROCESS WILL ALSO PROVIDE BUDGET NUMBERS FOR 2019/2020 BUDGET YEAR.

DPW BUILDING GENERAL CONTRACTOR

MOTION BY MARCH, SECONDED BY HAMM, TO AUTHORIZE THE PREPARATION OF SPECIFICATIONS FOR THE BUILDOUT ON THE NEW RATHJE ROAD PUBLIC WORKS BUILDING AND TO ADVERTISE FOR SEALED BIDS FOR A GENERAL CONTRACTOR FOR THE PROJECT. MARCH, HAMM, BOWDEN, MAREVKA, JONES, AND PARKER VOTING AYE; MOTION CARRIED.

THE RESOLUTION FOR IMPROVEMENT UNDER THE ILLINOIS HIGHWAY CODE AUTHORIZES THE USE OF MOTOR FUEL TAX FUNDS FOR THE CORNING AVENUE GRINDING AND RESURFACING PROJECT DESIGN ENGINEERING.

THE ADMINISTRATOR EXPLAINED THE NEW IDOT REQUIREMENTS FOR ANY FEDERALLY FUNDED PROJECTS WITH ENGINEERING OVER \$25,000.00. EACH COMMUNITY MUST DEVELOP THEIR OWN POLICIES AND PROCEDURES FOR QUALIFICATION BASED SELECTION (QBS). THE PROCEDURE IS TO REVIEW AND DETERMINE QUALIFIED ENGINEERS FOR PROJECTS.

NEW IDOT REQUIREMENTS

THE PRESIDENT REMINDED RESIDENTS NOT TO PARK ON THE STREETS AFTER A TWO-INCH SNOWFALL UNTIL THE STREETS HAVE BEEN PLOWED FROM CURB TO CURB.
