THE REGULAR MEETING OF THE PEOTONE VILLAGE BOARD OF TRUSTEES WAS CALLED TO ORDER AT 7:00 P.M. AT THE MUNICIPAL COMPLEX HALL, 208 E. MAIN STREET, PEOTONE, ILLINOIS; THE VILLAGE PRESIDENT, STEVEN CROSS, PRESIDING. THE FOLLOWING BOARD MEMBERS ANSWERED ROLL CALL: MS. MAREVKA, MR. JONES, MR. MARCH, MR. PARKER, AND MR. BOWDEN. TRUSTEE HAMM WAS ABSENT. ALSO PRESENT WERE THE CLERK, THE VILLAGE ADMINISTRATOR, ATTORNEY, ENGINEER, MS. BORMET, MR. RUSSELL, MR. KLEIN, AND SEVERAL AQUA REPRESENTATIVES.

**MINUTES** 

MOTION BY PARKER, SECONDED BY JONES, TO APPROVE THE PAYROLL AND TO APPROVE THE ACCOUNTS PAYABLE IN ALL CATEGORIZED FUNDS AS PRESENTED. PARKER, JONES, MAREVKA, MARCH, AND BOWDEN VOTING AYE; MOTION CARRIED.

PUBLIC COMMENT

ENGINEER REPORT - THE RTE. 50 MAST ARM FOR THE TRAFFIC SIGNAL HAS BEEN INSTALLED, THE CONCRETE WILL BE NEXT, AND IN TWO WEEKS THE SIDEWALKS WILL BE INSTALLED. THE PEOTONE- WILMINGTON RAILROAD CROSSING WILL BE CLOSED FOR FOUR TO FIVE DAYS. THERE HAVE BEEN ISSUES WITH THE DETOUR ROUTES.

**REPORTS** 

REPRESENTATIVES FROM AQUA ILLINOIS WERE PRESENT TO DISCUSS THE NEWS ITEMS REGARDING LEAD IN THE WATER OF SOME OF THEIR CUSTOMERS IN OTHER COMMUNITIES. THEY EXPLAINED THAT THE CHEMICAL AQUA USED TO CLEAR THE WATER PIPES TOOK THE INSIDE COATING OFF THE PIPES. THEY HAVE STOPPED THAT CHEMICAL AND WILL USE A DIFFERENT CHEMICAL TO PUT THE COATING BACK IN THE PIPES. THEY WILL BE DOING WATER TESTING EVERY MONTH INSTEAD OF EVERY THREE MONTHS. THE TIMELINE FOR THE WATERMAIN CONNECTION THE VILLAGE OF PEOTONE WAS DISCUSSED.

**AQUA LEAD UPDATE** 

THREE BIDS WERE RECEIVED FOR THE 2019 STREET PATCHING/RESURFACING PROJECT: GALLAGHER ASPHALT CORP. - \$175,837.30, IROQUOIS PAVING CORP. - \$176,383.95, AND P.T. FERRO CONST. CO. - \$181,566.35.

**2019 STREET PROJECT** 

MOTION BY JONES, SECONDED BY BOWDEN, TO AWARD THE 2019 STREET PATCHING/RESURFACING PROJECT TO THE LOWEST BIDDER, GALLAGHER ASPHALT CORP, IN THE AMOUNT OF \$175,837.30. JONES, BOWDEN, PARKER, MARCH, AND MAREVKA VOTING AYE; MOTION CARRIED.

THE ADMINISTRATIVE OVERSIGHT COMMITTEE MET WITH FIRST MIDWEST BANK AND PFM REGARDING THE INVESTMENT OF THE PROCEEDS FROM THE SALE OF THE WATER & SEWER SYSTEMS. THE RECOMMENDATION OF THE COMMITTEE WAS TO LEAVE \$3,124,511 WITH FIRST COMMUNITY BANK, MOVE \$2,2500,000 TO FIRST MIDWEST BANK, AND MOVE \$6,750,000 TO PFM.

AOC INVESTMENT RECOMMENDATION

REPRESENTATIVES FROM THE FIRST MIDWEST BANK EXPLAINED INVESTMENT ACCOUNTS AND HOW FDIC INSURANCE WORKED.

THE CONSENSUS OF THE BOARD WAS TO PROCEED WITH THE ADMINISTRATIVE OVERSIGHT COMMITTEE'S RECOMMENDATION.

THE ORDINANCE DENYS THE ENCROACHMENT OF 15 FEET INTO THE REQUIRED 30 FOOT SETBACK BUT WILL GRANT A VARIANCE TO ENCROACH 10 FEET INTO THE REQUIRED 30 FOOT SETBACK FROM THE BACK WALL OF THE HOUSE TO THE REAR OF THE PROPERTY.
