TRUSTEE JONES AND TRUSTEE BOWDEN WERE ABSENT. ALSO PRESENT WERE THE VILLAGE CLERK, MS. BORMET AND MS. AVIS.

MOTION BY MARCH, SECONDED BY PARKER, TO APPROVE THE BUSINESS REGISTRATION AS SUBMITTED BY MS. AVIS FOR MR. FRESH START TO BE LOCATED AT 112 W. CORNING AVENUE. MARCH, PARKER, HAMM, AND MAREVKA VOTING AYE; MOTION CARRIED.

THE PRESIDENT ANNOUNCED THAT DUE TO THE WEATHER, THE LEAF COLLECTION WAS AT A STANDSTILL UNTIL THE ICE AND SNOW MELTS. HE REMINDED RESIDENTS NOT TO RAKE/BLOW THE LEAVES INTO THE STREETS BECAUSE THE LEAVES BLOCK THE STORM DRAINS. THE PRESIDENT ALSO REMINDED THE RESIDENTS TO LOCK THEIR CARS TO HELP PREVENT THEFT.

GENERAL DISCUSSION

TRUSTEE MARCH INQUIRED ABOUT THE CHANGE IN THE WATER QUALITY. THE PRESIDENT REPLIED THAT THE WATER WAS BEING TREATED THE SAME WAY AS IN THE PAST. THE PRESIDENT THOUGHT THE HYDRANT FLUSHING WAS ON THE SAME SCHEDULE.

TRUSTEE MAREVKA INQUIRED ABOUT LOWER WATER PRESSURE SINCE THE FLOODING. THE PRESIDENT REPLIED THAT LOWER WATER PRESSURE WOULD HAVE NOTHING TO DO WITH THE FLOODING.
