#### **REVIEW 2023 CHRISTMAS IN THE VILLAGE EVENT**

THERE WERE SOME ISSUES WITH JR HIGH AGED CHILDREN NOT BEING WELL SUPERVISED, BEING DISRESPECTFUL TO VOLUTEERS IN AUTHORITY, HITTING EACH OTHER WITH THE LIGHT STICK HANDOUTS AND ALSO TRYING TO DAMAGE THE BLOW UP PHOTO OP. SOME PARENTS WERE HOLDING THEIR CHILDREN OVER THE BARRICADES DURING THE PARADE, WHICH WAS A SAFETY CONCERN. THERE WAS DISCUSSION ABOUT POSSIBLY USING BARRICADES ON ONE SIDE OF MAIN STREET FOR THE NEXT EVENT.

#### **DISCUSS 2024 CHRISTMAS IN THE VILLAGE EVENT**

THE HORSE AND CARRAIGE, PHOTO BOOTH, BALLOON ARTIST AND REINDEER ARE ALL SET FOR 2024 EVENT. THE SCHOOL IS AWARE OF THE DATE. WILL NEED TO HAVE FURTHER DISCUSSION AND POSSIBLY ADJUSTMENTS DEPENDING ON THE PROGRESS OF DOWNTOWN STREETSCAPE PROJECT AT LATER MEETINGS.
