SATURDAY, DECEMBER 10, 2022    LINE-UP BEGINS AT 4:00 PM    PARADE STARTS AT 5:00 PM

### LINE-UP IS ON SCHOOL PROPERTY - NO ALCOHOL OR SMOKING ALLOWED

LINE-UP WILL BEGIN AT 4:00 PM AT THE PEOTONE JUNIOR HIGH SCHOOL (1 BLUE DEVIL DRIVE). ENTER BLUE DEVIL DRIVE FROM GARFIELD AVENUE. ENTERIES WILL BE LINED-UP IN THE ORDER THEY ARRIVE. EMERGENCY VEHICLES WILL LEAD THE PARADE. HEIGHT RESTRICTIONS IS 14'6". THE PARADE ENDS AT THE INTERSECTION OF CRAWFORD AND CONRAD STREETS – PARADE ENTRANTS MAY DISBURSE AT THAT POINT.

### LIGHTED PARADE RULES:

- TO ASSURE SAFETY, NO CANDY OR OTHER ITEMS MAY BE THROWN FROM VEHICLES (CANDY/ITEMS MUST BE HANDED FROM PARADE WALKERS TO PARADE SPECTATORS)
- NO POLITICAL ITEMS OF ANY KIND ALLOWED TO BE PASSED OUT FROM PARADE PARTICIPANTS.

**VIOLATION OF THESE RULES WILL CAUSE YOU TO NOT BE ALLOWED TO PARTICIPATE IN NEXT YEAR'S PARADE**

- ALL ENTERIES MUST HAVE DECORATIVE LIGHTING
- HEIGHT RESTRICTION – 14'6"    WIDTH – 18'
- NO FULL SANTA CLAUS COSUMES/ THE REAL SANTA WILL BE IN THE PARADE
