H. Discussion Regarding Elimination of the Village Vehicle Sticker Program

There was discussion about eliminating the vehicle sticker program with the exception of the Non Highway Vehicles (golf carts) and dog tags. Staff looked at revenue and the cost to run the program and are looking for formal direction from the Board to either eliminate the sticker program or continuing to implement it. The Administrator and Mayor explained with the reduction in Community Development staffing, non property tax revenues, revenues increasing, optimizing future growth and freeing up staff

time spent that it would not be detrimental to eliminate them. Trustee Sluis expressed she is in favor of eliminating them. Trustee Sandberg stated he purchases multiple stickers and would want to make sure that the revenue is there to replace program revenue. Trustee Strba expressed concerns about wanting to make sure there is a revenue source to replace funds and about not implementing a food tax to replace funds, he said he would be ok with eliminating it if those items were addressed. Trustee Marevka stated she would be on board as long as the revenue is recouped elsewhere and stated that it could be helpful for residents. Trustee Richards said she was not opposed to eliminating it. The Mayor concluded that it is an unpopular program and eliminating it will free up staff time and having to deal with unhappy residents and recommends bringing the ordinance back to the Board in January for approval.





Ordinance amending Title III (Administration) of the Code of Peotone to add a New Chapter 41 (Electronic Participation in Meetings)

Background:

There are unique circumstances that occasionally prevent elected officials from participating inperson at board meetings. The demands of modern life have made required long-distance travel more common and competing demands for public official's time have grown. The proposed amendments to the Village Code articulate specific guidelines to allow for electronic participation at Village Board meetings if certain conditions are met.

For a member to participate, they must notify the Village Clerk before the meeting, unless impractical, so that the necessary communications equipment can be arranged. Inability to make the necessary technical arrangements will result in denial of a request for remote attendance.

Reasons why a member is unable to physically attend a meeting include:

- Personal illness or disability;
- Employment purposes or the business of the public body;
- Family or other emergency; or
- Unexpected childcare obligations.

After receiving an electronic attendance request, the Village Clerk will inform the board. Upon establishing a physical quorum at the meeting, the presiding officer will state that a notice was received in accordance with the established rules, confirm there is no opposition to the remote participation, and then establish that the member is deemed authorized to attend via electronic means.

AN ORDINANCE AMENDING TITLE III (ADMINISTRATION) OF THE CODE OF PEOTONE TO ADD A NEW CHAPTER 41 (ELECTRONIC PARTICIPATION IN MEETINGS) REGARDING ELECTRONIC PARTICIPATION IN MEETINGS

WHEREAS, the President and Board of Trustees of the Village of Peotone have full authority to regulate the conduct and procedures of their Village Board meetings as well as the public meetings of the Village's other boards, commissions and committees, subject to compliance with applicable State and Federal laws, like the Open Meetings Act (5 ILCS 120/1 et seq.); and

WHEREAS, the demands of modern life have made required long-distance travel more common, while at the same time the issues facing appointed and elected municipal officials are more serious, numerous and urgent than ever before; and

WHEREAS, the Illinois amends the Open Meetings Act authorizes public bodies under limited circumstances to allow their public officials the opportunity to attend and participate in open and closed public meetings through the use of telephone conference calls or other electronic means; and

WHEREAS, the President and Board of Trustees of the Village of Peotone find that there may be circumstances where a Village official may be absent from an open or closed board, committee or commission meeting, but that it is in the public interest to allow the absent Village official to participate, debate and vote on agenda items and issues that are discussed at such meetings through the use of telephone conference calls or other electronic means so that the business of the Village can be conducted in a timely and efficient manner with full input from all of the appointed and elected Village officials, and that it is in the best interests of the Village to codify the rules for such participation as set forth below.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Peotone, Will County, Illinois, as follows:

SECTION 1: Each whereas paragraph set forth above is incorporated by reference into this Section 1.

SECTION 2: Title III (Administration) of the Code of Peotone is amended by adding a new Chapter 41 (Electronic Participation in Meetings) to read in its entirety as follows:

CHAPTER 41: ELECTRONIC PARTICIPATION IN MEETINGS

SECTION:

40.01 Rules Statement

40.02 Definitions

40.03 Rules and Procedures

§ 41.01 RULES STATEMENT.

Consistent with the Illinois Open Meetings Act (5 ILCS 120/1 et seq.), the Village of Peotone desires to establish rules and procedures that will allow appointed and elected members of boards, commissions and committees to attend, participate and vote at open and closed public meetings through the use of telephone conference calls or other electronic means, provided that such attendance is in compliance with these rules and any applicable laws.

§ 41.02 DEFINITIONS.

<u>DEFINITIONS:</u> The definitions of the terms "meeting," "public body," "other means," "quorum" or any other defined term used in this Chapter, which are also found in the Open Meetings Act, shall have the same definitions as contained in the Open Meetings Act (5 ILCS 120/1 et seq.), as amended.

§ 41.03 RULES AND PROCEDURES.

- (A) Village boards, committees and commissions must comply with all of the applicable requirements of the Open Meetings Act (5 ILCS 120/1 et seq.), as amended.
- (B) Village boards, committees and commissions are prohibited from establishing a quorum to conduct business at an open or closed meeting through the attendance of board members by the use of telephone conference calls or other electronic means. A quorum of members of a Village board, commission or committee must be physically present at the location of an open or closed meeting.
- (C) Village officials who wish to attend a meeting through a telephone conference call or other electronic means must give notice before the commencement of the meeting to the recording secretary or the Village Clerk, unless advance notice is impractical. Inability to make the necessary technical arrangements to allow electronic participation will result in denial of a request for remote attendance.
- (D) Meeting minutes must reflect whether a member is present physically or electronically, regardless of whether any members are attending through the use of a telephone conference call or other electronic means.
- (E) Provided that the audio, telephone or video conference connection allows the voice of an absent member to be clearly heard by the attendees of the meeting (including the public) and the absent member can clearly hear the voices of the attendees who participate in the meeting, a member of a Village board, committee and commission may attend, participate and vote at an open or closed meeting through the use of a telephone conference call or other electronic means if the member is prevented from physically attending because of:
 - personal illness or disability;
 - (2) employment purposes or the business of the public body;
 - (3) a family or other emergency; or
 - (4) unexpected childcare obligations.

- Where one or more members of a Village board, committee and commission is attending the meeting by use of a telephone conference call or other electronic means, the presiding officer shall, immediately after convening of the meeting, announce to the public which member is attending the meeting by use of a telephone conference call or other electronic means, identify the method of attendance and the reason why the absent member is participating by such means. The member will be deemed authorized to attend the meeting electronically unless a motion objecting to the member's electronic attendance is made, seconded, and approved by two-thirds (2/3) of the members of the public body physically present at the meeting. If no such motion is made and seconded or if any such motion fails to achieve the required vote by the members of the public body physically present at the meeting, then the request by the member to attend the meeting through a telephone conference call or other electronic means shall be deemed approved by the public body and the presiding officer shall declare the requesting member present. After such declaration by the presiding officer, the question of a member's electronic attendance may not be reconsidered.
- (G) If the presiding officer of the public body is attending the meeting by telephone conference call or other electronic means, then the person who acts in the absence of the presiding officer shall chair the meeting. If there is none, then the presiding officer shall appoint a member of the public body who is physically present at the meeting to serve as chair of the meeting. The appointment of a chair shall be subject to the advice and consent of the public body. The presiding officer who is participating by electronic means shall be authorized to participate in the meeting to the extent authorized by law or ordinance except for those acts involved with chairing the meeting.
- (H) The voice of the absent member participating by telephone conference call or other electronic means, after being identified by the other Village board, committee and commission members as belonging to the absent member, shall be simultaneously broadcast to the public present at the meeting so that his or her voice can be heard, and the member shall also be able to hear any discussions of the other members and the public comment regarding any issue discussed at the meeting before a vote is taken.
- **SECTION 3:** All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.
- **SECTION 4**: Each section, paragraph, clause and provision of this Ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.
- **SECTION 5**: Except as to the Code provisions set forth above in this Ordinance, all chapters and sections of the Code of Peotone, as amended, shall remain in full force and effect.
- <u>SECTION 6</u>: To the extent necessary, all table of contents, indexes, headings and internal references or cross-references to sections contained in the Code of Peotone, as amended, that have been deleted or amended by the Code Amendments set forth above, shall be amended by the Village's codifier so as to be consistent with the Code Amendments of this Ordinance.
- **SECTION 7**: This Ordinance shall be in full force and effect from and after its adoption, approval, and publication in pamphlet form as provided by law.

These amendments to the Village Code addresses previous concerns and puts the Village on more solid ground when it comes to enforcement of violations and other questions of allowed parking on various Village streets.

AN ORDINANCE AMENDING SECTION 72.01 (VEHICLE PARKING) OF CHAPTER 72 (PARKING REGULATIONS) OF THE VILLAGE CODE OF THE VILLAGE OF PEOTONE REGARDING PARKING

WHEREAS, the Village of Peotone ("Village") is a non-home rule unit of local government as provided by Article VII, Section 7 of the Illinois Constitution of 1970: and

WHEREAS, the Village President and Board of Trustees of the Village have previously enacted Chapter 72 (Parking Regulations) of the Village Code of the Village of Peotone to administer parking rules and penalties within the Village.

WHEREAS, the President and Board of Trustees now find it in the best interests of the Village to make certain amendments to Chapter 72, to conform the Chapter to the Village's existing practices and conditions and to make other minor changes, as set forth below.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Peotone, Will County, Illinois, as follows:

SECTION 1: Each whereas paragraph set forth above is hereby incorporated by reference into this Section 1.

SECTION 2: Section 72.01 (Vehicle Parking) of Chapter 72 (Parking Regulations) of the Village Code of the Village of Peotone is amended to read in its entirety as follows:

"§ 72.01 VEHICLE PARKING.

(A) It shall be unlawful to park any vehicle on the following public streets in the village on each and every day of the week between the hours of 2:00 a.m. and 6:00 a.m.

Main Street from First Street to Railroad Street

Second Street from Main Street to Crawford Street

North Street from Railroad Street to Second Street

- (B) It shall be unlawful to park any vehicle on residential streets within the Village of Peotone between the hours of 8:00 p.m. and 6:00 a.m. with any license plate issues by the state of Illinois exceeding Class B plates or out of state registrations over 8,000 pounds.
- (C) It shall be unlawful to park any vehicle on the following streets in the village at any time on each and every day of the week:

No parking on both sides of West Street from Joliet Road to Crawford Avenue.

No parking on the north side of Main Street from Route 50 to Third Street.

No parking on the west side of First Street from Wilson Street to Corning Avenue.

No parking on the north side of Hauert Street west of Sixth Street, from the point where the street begins to curve south, to the intersection with Route 50, approximately 350 feet.

No parking on the north side of Crawford <u>StreetAvenue</u> from Route 50 to the existing railroad tracks.

No parking on the south side of Crawford <u>StreetAvenue</u> from Route 50 to the west side of the driveway located at 432 East Crawford <u>StreetAvenue</u>.

No parking on the north side of West North Street from First Street to Second Street.

No parking on both sides of Oriole Drive from Wilmington Road to Teal Avenue.

No parking on the north side of Louise Lane from the northeast corner of the intersection of Louise Lane and Locust Lane to a point 185 feet east of said intersection.

No parking on both sides of Teal Avenue west of Oriole Drive.

No parking on both sides of Garfield Avenue from the intersection of Garfield Avenue and Mill Street east for a distance of 100 feet.

No parking on both sides of Mill Street from the intersection of Mill Street and Garfield Avenue north for a distance of 100 feet.

No parking on the east side of West Street from the intersection of West Street and Corning Avenue to a point 175 feet north of said intersection.

No parking on the east side of Division Street from its intersection with Crown Lane to a point 220 feet to the south.

No parking on the north side of Crown Lane from its intersection with Division Street to a point 120 feet to the west.

No parking on both sides of West Street between Corning Avenue and Wilmington Peotone Road.

No parking on the north side of West Wilson Street between the railroad and First Street.

- No parking on the south side of Sumner Avenue from Second St to West Street.
- No parking on the south side of Lincoln Street from Washington Street to West Street.
- No parking on the east side of Second Street from Crawford Street to Lincoln Street
- No parking on the east side of First Street from Crawford Street to Sumner Avenue.
- No parking on the south side of North Street from West Street to Conrad Street.
- No parking on both sides of Corning Avenue from Route 50 to the driveway of 413 East Corning Avenue on the north side, and the driveway of 408 East Corning Avenue on the south side.
- No parking on the east side of Fourth Street from South Street to Crawford Street.
- No Parking on the south side of South Street from Second Street to Route 50.
- No parking on the south side of Wilson Street from Second Street to Fourth Street.
- No parking on the west side of Schoeder Avenue from Jessen Street to Wilmington Road.
- No parking on both sides of Jessen Street from Second Street to Schroeder Avenue
- No parking on the west side of Second Street from Wilson Street to South Street.
- No parking on the west side of Railroad Street from Wilson Street to North Street.
- No parking on the north side of North Street from Route 50 to the railroad tracks.

- (D) It shall be unlawful to park any vehicle on the west side of West Street between Crawford Avenue and Corning Avenue from 9:00 a.m. to noon on Sundays.
- (E) It shall be unlawful to park any vehicle on the following public streets as these streets border the Will County Fairgrounds (as posted) between the hours of 12:01 a.m. on the first day of the Will County Fair and 11:59 p.m. on the last day of the Will County Fair:

Both sides of Division, Crown, Royal and Manor Streets.

Both sides of Rathje Road from Wilmington Road to Corning Avenue.

- (F) It shall be unlawful to park any vehicle on the following public streets as these streets border the Will County Fairgrounds (as posted) between the hours of 12:01 a.m. and 11:59 p.m. on the date of the Tri-Chevy Show held at the Will County Fairgrounds:
- Both sides of Division, Crown, Royal and Manor Streets.
- Both sides of Rathje Road from Wilmington Road to Corning Avenue.
- (G) It shall be unlawful to park any vehicle on Conrad Street (both sides) from Joliet Road to Crawford on Monday through Friday from 8:00 a.m. to 8:30 a.m. and from 3:00 p.m. to 3:30 p.m.
- (H) (1) Definitions. For the purpose of this division (H), the following definitions shall apply unless the context clearly indicates or requires a different meaning.

OWNER OF VEHICLE. That person to whom the automobile is titled according to the then current records of the Secretary of State.

RESIDENT. A person residing in a residential premises located adjacent to the street upon which parking is prohibited hereby.

- (2) Streets. Between the hours of 8:00 a.m. through 4:00 p.m. Monday through Friday, parking on the following streets shall be limited to residents:
- (a) That portion of North Street lying east of Rathje Road, thence east until the terminus of Rathje Road in the Ashburton Estate Subdivision (both sides of the street);
 - (b) Ashburton Lane (both sides of the street);
- (c) The Hague Street (located within Ashburton Estate Subdivision, both sides of the street); and
 - (d) Hans Brinker Drive, both sides of the street (located in Ashburton Estates).
- (IG) It shall be unlawful to park any vehicle on the following streets in the village between the hours of 2:30 p.m. and 3:30 p.m. on any day school is in session:

Mill Street between Joliet Road and Glenview Lane

The south side of Garfield Avenue between Mill Street and West Street

- (JH) It shall be unlawful for ana person to park or for the owner of a motor vehicle to permit it to be parked as follows:
 - (1) On, across or in any way blocking a sidewalk;
 - (2) In a parkway;
 - Blocking a driveway;
 - (4) In an intersection or crosswalk;

- (5) In a viaduct;
- (6) Within 15 feet of a fire hydrant;
- (7) In a bus stop, loading zone or cab stand;
- (8) The wrong way on a one-way street;
- (9) More than 12 inches from the curb;
- (10) Double parked;
- (11) On a two-way street so that the driver's side of the car is nearest to the curb;
- (12) In the parking space designated "Police Parking Only" on Main Street in front of the police station; andor
- (13) In any other place designated as a temporary no-parking area by the Chief of Police and so marked.
- (KI) It shall be prohibited to park any motor vehicle which is not bearing registration plates or decals issued to a handicapped person, as defined by ILCS Ch. 625, Act 5, § 1-159.1, pursuant to ILCS Ch. 625, Act 5, § 11-301.1, or to a disabled veteran pursuant to ILCS Ch. 625, Act 5, § 3-609, as evidence that the vehicle is operated by or for a handicapped person or disabled veteran, in any parking place, including any private or public off street parking facility, specifically reserved, by the posting of an official sign as designated by ILCS Ch. 625, Act 5, § 11-301.1, for motor vehicles bearing such registration plates. Any motor vehicle bearing a handicapped license plate or a handicapped parking decal or device containing the international symbol of access issued to handicapped persons by any local authority, state, district, territory, or foreign country shall be recognized as a valid license plate or device and receive the handicapped parking privileges. Any person owning or operating any public or private off street parking facility may. after notifying the Peotone Police Department, remove or cause to be removed to the nearest garage or other place of safety any vehicle parked within a stall or space reserved for use by the handicapped which does not display handicapped registration plates or a special decal or device as required by this section. Any person violating the provisions of this section shall be fined \$350 in addition to any costs or charges connected with the removal or storage of any motor vehicle authorized under this section.
- (الحال) It shall be unlawful for the operator of any vehicle to turn left into any parking place where such turns are prohibited by ordinance. Such prohibition shall be indicated by appropriate signs.
- (MK) In all parking spaces administered by the Village of Peotone, all vehicles shall be parked with the front end of the vehicle facing into the space provided for parking. It shall be unlawful for any person to back any vehicle into such parking space. No person shall stand or park a vehicle other than at the angle to the curb or into the roadway other than as indicated by signs or markings.
- (NL) It shall be unlawful to park either a semitrailer or any truck tractor on any public street, highway, or other public place located within the boundaries of the village except within an industrial zone. Except as otherwise posted to the contrary, it shall also be unlawful to park either a semitrailer or any truck tractor on any property located within the village not zoned for industrial use unless the semitrailer or truck tractor is placed within a garage or other appropriate building such that it is not open to public view.
- (OM) Vehicles must be parked on a hard surface, defined as concrete or asphalt. This applies to any location on the property where a vehicle is parked. An existing drive of gravel as of this ordinance date may be used. No increase in driveway or parking area may be made in gravel for the purpose of parking additional vehicles."

SECTION 3: All Ordinances, and parts of Ordinances, in conflict with, or inconsistent with, the provisions of this Ordinance are hereby repealed to the extent of any such conflict or inconsistency.

SECTION 4: If any part or portion of this Ordnance shall be declared invalid by a Court of competent jurisdiction, such partial invalidity shall not affect the remainder of this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect upon its passage, approval and publication in pamphlet form as provided by law.
