Barb Sim, President of the Peotone Park District, was present. She had an informational handout and spoke about the decision the Park District board made to go out for a referendum in March to ask for a tax increase of .0547 to help with new playground equipment, ball field improvements and vehicle maintenance. They have created a 20-year plan and also have some grant funding. It has already been presented to the County Clerks Office and will be on the March ballot. B. Capital Improvement Plan Workshop

A handout was presented in the packet and Annmarie Mampe was present to answer any questions. This is the beginning of the budget process and is the budget proposed by staff at this time. An overview was given of the various funds and funding sources. Board consensus was to move forward.

For Items C, D and E: The Police Chief gave an overview as the three ordinances on the agenda all work together with adjudication. Currently ordinance tickets go to court in Frankfort where the judge makes a decision, and we have to pay court costs. Adjudication will be handled in house and the Village will have more control and will help work with residents for collection. Peotone would combine with Beecher and split the cost of the adjudicator, this would also absorb administrative tows. This would not be adding any employees, but the Village would be paying a portion of the adjudicator cost which will be approximately \$100 more a month than we currently pay for tow hearings but the Village will be capturing more of the fines instead of the Court collecting and there will be more personal attention to the community and the residents will have lower fees. There was discussion about removing the late penalty as there is a fee schedule and the Attorney will make changes to the Ordinance.
