V. Staff Committee Reports:

- **A.** Engineer Troy reported that the storm sewer work on the streetscape is finished, there is no conflict with the water mains and excavation will be starting this week. The Crawford Street MFT resurfacing project will be submitted to IDOT and will be out to bid in early June. Waiting on the water main design for the Conrad Street project. D Construction has installed raised reflective markers and fixed some striping, still waiting on some signage and the sidewalk around 88th Ave. Damaged guard rails have been reported to both Will County and IDOT.
- **B.** Christmas Committee Trustee Strba reported the Committee met and discussed sponsorship letters, food trucks and the parade route, next meeting will be in July.
- C. **Public Works Committee** Trustee Strba reported the Committee met and discussed part time help, possibly hiring a full time employee next year, a new skid steer and tree planting in the fall.
